## How To Generate Sales Tax Report In Quicken For Mac

It's the "granddaddy" of personal finance software, appearing first for MS-DOS and Apple II (remember them?) back in 1983.. Times have changed, and now Quicken has multiple versions of its application — from Window and Mac to apps for the iPhone, iPad and Android.. Quicken's desktop software can sync up with the mobile app But changing times have also brought a changing playing field for these types of applications.. It is a cloud-based service, and you can access Mint via any web browser or mobile app on your iPhone or Android smartphone.. While you can't modify the top-level categories, you can create and add your own subcategories.. The Mint app was started in 2006 and was acquired by Intuit in 2009 While Quicken used to be Intuit's lead product, Mint has become their sole focus since announcing the sale of Quicken.. EnPass is the best way to go if you prefer a completely free password manager The Mac desktop app has all the features and there are no subscription charges or sign-up required..
